The meeting will be held on Monday, September 16, 2024, at 11:00 a.m.


The Board shall consider and discuss the following matters and take any action necessary or appropriate with respect to such matters:

1. Public comments;
2. Review and approval of the minutes of the Board meeting held on August 19, 2024;
3. Review and discussion of the monthly activity reports prepared by the Fort Bend County Sheriff's Office and Fort Bend County Precinct 1 Constable's Office;
4. Conduct a public hearing regarding the adoption of the District's proposed 2024 tax rate;
5. Levy of the District's 2024 taxes, and the adoption of an Order in connection therewith;
6. Approval and execution of an Amendment to the Amended and Restated District Information Form regarding the 2024 tax rate;
7. Bookkeeper's Report, including financial and investment reports; authorize the payment of invoices presented;
8. Tax Assessor-Collector's Report, including status of delinquent taxes; authorize the payment of invoices presented, approval of tax refunds, and transfer of accounts to the uncollectible roll;
9. Review of Delinquent Tax Collection Attorneys' Report from Perdue, Brandon, Fielder, Collins & Mott, L.L.P.; authorize any action necessary and appropriate in connection therewith, including authorizing foreclosure proceedings, installment agreements, and the filing of proofs of claim;
10. Sales Tax Revenue Status Report;
11. Operation and Maintenance Report, including:
 - A. Monthly report;
 - B. Appeals of District charges and other customer billing matters;
 - C. Repair and maintenance of District facilities, including consideration of any contracts for same and authorize acceptance of Texas Ethics Commission Form 1295 ("TEC Form 1295");
 - D. Refer accounts for collection;
 - E. Approve write-off of uncollectible accounts;
 - F. Compliance with permits and regulatory requirements, including review of any notices of violations, responses to notices and remedial action taken, self-reporting forms as and if required, and correspondence to and from

- G. regulatory agencies regarding same;
 - G. Reclaimed water system and irrigation; and Storm Sewer Survey Report; and
 - H. Discussion of Tackle Construction Co., Inc. estimate for repair of sinkhole and interior and exterior of manhole around 42-inch storm pipe;
12. **Engineer's Report, including:**
- A. Authorizing the design and/or advertisement for bids for construction of facilities within the District, and approving of related storm water plans;
 - B. Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of the District, and the execution of any documentation in connection therewith, including wastewater treatment plant site permit;
 - C. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, and approval of any related storm water permits and authorize acceptance of TEC Form 1295;
 - D. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders and authorize acceptance of TEC Form 1295 related to same;
 - E. Acceptance of site and/or easement conveyances for facilities constructed or to be constructed for the District, and acceptance of facilities for operation and maintenance purposes;
 - F. Review and approval of amended Capital Improvement Plan;
 - G. Discussion regarding the repair of the sinkhole located over the top of a 54-inch storm sewer located adjacent to the median of Fry Road; consider proposal for repairs and authorize acceptance of TEC Form 1295 related to same; and
 - H. Discussion of Reclaimed Irrigation System, including:
 - i. Discussion of reclaimed water emergency interconnect and review of cost estimate relative to same; and
 - ii. Review estimate to connect new waterline to Reclaim Ground Storage Tank for backup water source;
